



Capacity Building Workshop on Asset Monetization and Tariff Based Competitive Bidding

Date: October 30, 2023, 2023; Time: 11:00 - 16:00 IST

Background:

The South Asia Regional Energy Partnership (SAREP) is a five-year program of the U.S. Agency for International Development (USAID) which aims to improve access to affordable, reliable, and sustainable energy in India and South-Asian countries. SAREP is a key initiative under USAID's bilateral engagement with the Ministry of Power and the Ministry of New and Renewable Energy (MNRE), Government of India. Through the SAREP program, USAID partners with six states to support wide-scale deployment of clean energy and modernization of power utilities through technical assistance and capacity building. Madhya Pradesh (MP) was identified as one of the partner states in consultation with MOP for technical assistance across multiple interventions.

Based on discussion with senior management of Madhya Pradesh Power Transmission Corp. Ltd. (MPPTCL), the following areas were identified for collaboration with USAID's SAREP Program:

- Capacity building for Asset Monetization
- Capacity building for participation in Tariff Based Competitive Bidding (TBCB)
- Capacity gap assessment and handholding of State Transmission Utility and State Load Dispatch Center

Objective:

The interactive orientation workshop on October 30, 2023 will

- Introduce officials of MPPTCL to the concept of asset monetization, existing models, major challenges, framework for selection of assets and way forward.
- Provide brief overview of tariff-based competitive bidding policy and regulatory structure, bidding and procurement framework, valuation methodology, compliance with qualification and other legal requirements.

Post the knowledge sharing workshop, SAREP will assess the overall understanding of MPPTCL officials on these topics, identify topics that would need in-depth handholding, and curate detailed training program. This workshop will also help in bringing consensus and a common understanding on the asset monetization and tariff-based competitive bidding.
